**Ans.** NO! but at the discretion of the Executive Committee of the Association, if in special case instalment is granted but if within a month next part is not paid, the amount deposited earlier shall be forfeited. Amount deposited is neither refundable nor transferable.

**9) What are the minimum and maximum age limit for seeking Membership?**

**Ans.** Minimum age limit is 14 Years and after 60 Years of age, no membership is granted. In special cases, if so, the enrolled persons do not get certain benefits of the Association.

**10) What is the minimum qualification for getting membership of your Association?**

**Ans.** Minimum Diploma Exam passed in Allied Health Care Professionals.

**11) Is there any prescribed application form for applying to get the IPMA Membership?**

**Ans.** Yes! You may apply on prescribed form available in the office and association website, fill it up, get recommendation from two bonafide sound Recordists with essential testimonials. You may download application form from our official website and shall have to pay Rs. 1170/- at the time of submission of the application as its prescribed cost.
